- This independent/partner reading packet
- Ghost Boys by Jewell Parker Rhodes
- Fluency passage packet at assigned level

For families:

This packet is designed to guide your students through the work of reading and comprehending the Unit 2.1 novel, *Ghost Boys*, by Jewell Parker Rhodes. Students may use the packet independently, working at home.

How can I support my child in completing this packet?

STARI is meant to be a **discussion-based curriculum**. In fact, our research shows that it is students' talk about text that builds their comprehension skills. Therefore, we encourage you to try to find any possible opportunities for students to engage in talk about text. Could students connect with their partners virtually, to talk via phone or computer? Could you, or a sibling or other family member, read the novel and talk about it with your child? The more students are able to talk about the text, the more improvement in their skills we expect to see.

How should students use the fluency packets?

STARI students have been assigned a fluency level: A, B, C, or D. They have been taught a 2-day fluency routine. The steps of the routine can be found on pp. 3-4 of the packet. Students should engage in this 2-day routine one to two times per week. Each day of the routine involves a timed reading of the assigned passage. If students are able to pair up with someone (parent or family member, or online partner) to time them, that is ideal. Alternatively, they can record themselves reading and use the recording to time themselves, or submit the recording to their teacher.

How can we access the novel?

The novel for this unit is *Ghost Boys*, by Jewell Parker Rhodes. Many schools are providing students with PDFs or hard copies of assigned texts. If that is not the case for your school, this book is generally easily available for purchase. Your local bookstore or an online retailer may be able to ship it to you, or you can buy a digital copy. Alternatively, you may be able to check out a digital or hard copy from your local library. Finally, some STARI schools have directed students to online free libraries such as Open Library and National Emergency Library.

This packet is no substitute for the rich discussion that takes place in STARI classrooms, but we hope that it provides continuing support for students in these difficult times. For more information, contact your child's teacher or visit <u>serpinstitute.org/stari/distance-learning</u>.







But I don't have the book! If you are not able to get the book from school, try downloading a copy from your local library, or Open Library, or National Emergency Library. You can read it on your phone.

This isn't the same as reading in class with your teacher. But you can do it!

Jewell Parker Rhodes



"I'm Gonna Be A Storyteller!"

Jewell Parker Rhodes has always loved books. As a child, her family called her "the little professor" because all she ever wanted to do was read. She wrote stories all the time. But she never considered becoming an author.

Why not? Rhodes says, "I had never read a book by a Black person or any person of color until I became a junior in college. And when I saw that Black women could write books, that was when I decided, that's going to be my profession." She called her grandmother, who had raised her. She said to her, "I'm gonna be a storyteller!"

Today, she has written over a dozen books, both for kids and adults. Her young adult books focus on controversial subjects. One book, *Ghost Boys*, is about police violence. Another, *Towers Falling*, is about the September 11 attacks on America. She has also written the Louisiana Girls trilogy: three books about strong Black girls in Louisiana, in different time periods.





Jewell Parker Rhodes believes in ghosts



Jerome's grandma says, "Every goodbye ain't gone." This is an African-American saying that Jewell Parker Rhodes believes.

Rhodes was raised by her grandmother. One week after Rhodes called to say she had decided to be a writer, her grandmother died. She died in a hospital elevator. She chose to go to the only hospital in Pittsburgh that allowed Black doctors. They didn't have the equipment they needed to save her life on the first floor.

Rhodes believes her grandmother is still with her. She says, "I feel her presence every single day. I feel that I can access her, her goodness, her love, and it restores me."

Rhodes says that believing in ghosts is an African-American tradition. She says that many African faiths believe that everything has a spirit. And those spirits don't disappear. We should honor the spirits of our ancestors. "The dead are still with us," she says.



Jewell Parker Rhodes didn't want to write Ghost Boys

Jewell Parker Rhodes described her process of writing *Ghost Boys*. "I think I resisted every step of the way writing this book," she said. "The book was not my idea. It was my editor's idea."

Rhodes wrote 27 pages, and thought she was done. She said her first draft of the book "was just sadness. Jerome was shot. He died. We saw the bleakness in his family, went to the courthouse and saw the police officer was set free. And he had such rage and a sense that the world was unjust."

Later, she came back to those 27 pages. She said, "That isn't good enough. Because life is much more complicated. People are much more complicated. I think that I didn't quite yet have that depth of compassion for all my characters. You know a fiction writer has to love all their characters."

But how could Rhodes bring herself to love the character of Officer Moore? The answer came when she created the character of Sarah. She said, "Sarah would immediately humanize the police officer."

But that wasn't the only reason Rhodes included this character. She said, "It was important to me that there be Carlos as an Hispanic boy, Jerome as an African American boy, and this wondrous White girl, who through their multiethnic backgrounds are ready to move the world forward."





For years, the sign was covered with bullet holes. Set near a river in Mississippi, the sign remembered Emmett Till. It marked where Emmett Till's body was pulled from the river. This is an important spot in Civil Rights history. It is also a target for vandalism by White supremacists.

The first sign was raised on the site in 2008. However, it was stolen and never recovered. The second sign stood until 2016. It was covered with bullet holes for years before it was replaced. The third sign was shot up within just 35 days.

Some believed the sign should be left up with the bullet holes. "It's really indicative of the fact that racism is yet alive," said Airickca Gordon-Taylor. Gordon-Taylor is related to Emmett Till. She directs a foundation that preserves his memory.

In 2019, a new sign was put up. The new marker weighs over 500 pounds and is bulletproof. It is protected from vandalism by a layer of glass. New, motion-detecting cameras also help prevent vandalism. Gordon-Taylor appreciates how the new sign preserves the site's history. It explains how past signs were stolen and defaced. It reminds readers "of the progress yet to be made."





- Laquan McDonald was killed on October 20, 2014 in Chicago, Illinois. He was 17 years old. Laquan was shot 16 times by Officer Van Dyke of the Chicago police. Van Dyke claimed Laquan was threatening him with a knife. But the video showed something different. Laquan was walking away from Officer Van Dyke when he was shot. Van Dyke was found guilty of murder and sentenced to six years in prison.
- Michael Brown was killed on August 9, 2014 in Ferguson, Missouri. He was 18 years old. He was shot by a White police officer named Darren Wilson. Wilson claimed that Michael attacked him while he was sitting in his police car. He said Michael was trying to get his gun. Michael's friend Dorian Johnson was also there. Dorian said Officer Wilson started it by reaching out his car window and grabbing Michael by the neck. Michael and Dorian ran away and Officer Wilson pursued them. Wilson said that Michael turned around and began running toward him, as Officer Wilson was shooting at him. A jury decided not to charge Officer Wilson with a crime.
- Jordan Edwards was killed on April 29, 2017 in Balch Springs, Texas. He was 15. He was shot by Officer Roy Oliver. The police were called to break up a party. Jordan and his brother got into his brother's car to try to leave. Officer Oliver tried to stop the car, but they drove away. Officer Oliver fired into the car, hitting Jordan in the back of the head. Officer Oliver was sentenced to 15 years in prison.
